Hurricane Fire Department Report

Deron Wilkes reported that the Department had 78 calls for service. 44 calls were between 8:00 a.m. and 4:00 p.m. October is Fire Prevention month.

City Manager's Report

Ben Newhouse, City Manager reported that a Putnam County Cleanup is scheduled for September 25th at Valley Park. Water Board approved to start purchasing the "touch read

meters". New Stormwater Coordinator has been hired, Tim Weddington. Tim is working under Ronnie Woodall and met with DEP officials.
