## Youth Athletic Equipment Endowment Application

**Youth Athletic Endowment Information:** The City of Hurricane, through the Hurricane Development Authority Board, will provide assistance in the form of athletic equipment and/or uniform needs to City of Hurricane athletic participants under the age of 17 years of age. Endowments are limited to **two awards** per Family/members of the same address per year, provided funds are available. Recipients **may not** be eligible if an endowment has been awarded in previous year. Incomplete or misleading applications will be rejected. **All scholarships are awarded based on demonstrated need, available funding and meeting all deadline requirements. Awards are made at the sole discretion of the sponsor.**

**Registration Information:** Recipients will be notified no later than four (4) weeks after the application has been received. If approved, than recipients will be issued a confirmation letter/email. Recipient will then be awarded equipment based on the information within the application. The City of Hurricane is not responsible for any damages/injuries and/or issues with purchased equipment once in the possession of the recipient. Please be detailed in application for equipment/uniform needs.

**Participant Endowment Criteria:** In need of financial assistance as outlined below; age 17 and under; City of Hurricane resident; participation on an athletic organization within Hurricane City limits; complete application (including supplemental information); meet eligibility to participate on said Hurricane athletic organization; is not a recipient of any other scholarship program pertaining to athletics.

**Application Instructions (Complete one application per participant):** Parent/legal guardian must complete the questions below. Information must be signed by coach of listed Hurricane athletic group/team in which applicant plays for/on. Applications that are received typically will take 45 days to process.
